1. The June Town of Eden board meeting was called to order at 7:00 p.m. by Chairman Rick Zemlicka. Jacob moved that proper meeting notice was posted. Seconded by Dennis. Motion carried.
2. Motion by Jacob to approve agenda as is, seconded by Dennis, motion carried.
3. Cheryl read the minutes of the May Regular Town Board meeting. Jacob motioned to accept the minutes as read, seconded by Dennis, motion carried.
4. Rick inquired if there was any public comment. No public comment.
5. The board asked Brian if he received any written confirmation of options for the new truck equipment. None received and Brian will request again. Jacob motioned to table the discussion to the July meeting, seconded by Dennis, motion carried.
6. Rick reported that he received an estimate from Hying Hardware of \$250.00 to decommission one of the two bathrooms, removing fixtures and cap plumbing. Jacob motioned to approve of the decommissioning, seconded by Dennis, motion carried.
7. Matt Anderson applied for approval of a driveway by submitting the Iowa County Office of Planning & Development Town Driveway Approval form and paid the \$100.00 required fee. Rick will conduct an inspection of the driveway to ensure full compliance of all of the provisions of the Town of Eden Driveway Ordinance.
8. The board opened and reviewed bids for sealcoat work and culvert replacements.
 - a. Jacob motioned to hire Keving Wienkes to do ditch work and seven culverts. Seconded by Dennis. Motion carried.
 - b. Motion to table Blue River Rd. by Jacob and seconded by Dennis. Motion carried.
 - c. Wedging work: Jacob motioned to award Iverson Construction (Bid #3972), seconded by Rick. Motion carried.
 - d. Seal Coating: Motion by Jacob to award Scott Construction (Bid #SO25009), seconded by Rick. Motion carried.
 - e. Jacob moved to accept bid from Scott Construction to crack fill and seal coat around the Salt Shed. Rick seconded. Motion carried.
9. Cheryl presented liquor license renewals from Tower Junction, Baskets and Beyond, and Blackhawk Outdoors. She also presented four operators licenses from Tower Junction, and a cigarette license from Blackhawk Outdoors. Dennis moved to approve the licenses for the same fee as last year. Jacob seconded the motion. Motion carried.
10. Jennifer read the treasurer's report and presented the monthly bills which were discussed. Jacob motioned to accept the treasurer report and monthly bills as presented, seconded by Dennis, motion carried.
 - a. Jacob motioned to purchase printable checks, seconded by Dennis, motion carried.
 - b. Jacob motioned approval for treasurer to pay any reoccurring bill presented after any monthly meeting. Dennis seconded the motion, motion carried.

11. Brian presented his patrolman's report stating he continues to mow roadways. He requested the purchase of a hydraulic broom to help clean the roadways and a sprayer. Add to the July regular town meeting under new business.
12. Brian requested direct deposit for his paycheck.
13. Rick reported about the Badger Wind Farm and the future Public Service Commission Public Hearing.
