Ordinance No. 20252

- 1.1 Title.** Garbage and Recycling Ordinance for Town of Eden, Iowa County, Wisconsin
- 1.2 Purpose.** The purpose of this ordinance is to promote recycling, composting, and resource recovery through the administration of an effective recycling program, as provided in s. 287.11, Wis. Stats., and ch. NR 544, Wis. Adm. Code.
- 1.3 Statutory Authority.** This ordinance is adopted as authorized under s. 287.09(3)(b), Wis. Stats., and the Town of Eden, Iowa County, Wisconsin.
- 1.4 Abrogation and Greater Restrictions.** It is not intended by this ordinance to repeal, abrogate, annul, impair or interfere with any existing rules, regulations, ordinances or permits previously adopted or issued pursuant to law. However, whenever this ordinance imposes greater restrictions, the provisions of this ordinance shall apply.
- 1.5 Interpretation.** In their interpretation and application, the provisions of this ordinance shall be held to be the minimum requirements and shall not be deemed a limitation or repeal of any other power granted by the Wisconsin Statutes. Where any terms or requirements of this ordinance may be inconsistent or conflicting, the more restrictive requirements or interpretation shall apply. Where a provision of this ordinance is required by Wisconsin Statutes, or by a standard in ch. NR 544, Wis. Adm. Code, and where the ordinance provision is unclear, the provision shall be interpreted in light of the Wisconsin Statutes and the ch. NR 544 standards in effect on the date of the adoption of this ordinance, or in effect on the date of the most recent text amendment to this ordinance.
- 1.6 Severability.** Should any portion of this ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of this ordinance shall not be affected.
- 1.7 Applicability.** The requirements of this ordinance apply to all persons within The Town of Eden, Iowa County, Wisconsin.
- 1.8 Administration.** The provisions of this ordinance shall be administered by the Town Board.
- 1.9 Effective Date.** The provisions of this ordinance shall take effect on April 7, 2026
- 1.10 Definitions.** For the purpose of this ordinance:
- 1) "Bi-metal container" means a container for carbonated or malt beverages that is made primarily of a combination of steel and aluminum.

- 2) "Container board" means corrugated paperboard used in the manufacture of shipping containers and related products.
- 3) "Electronic Waste (E-Waste)" mean discarded electronic devices, including but not limited to computers, monitors, televisions, printers, keyboards, mice, cell phones, and other electronic equipment as specified in Section 1.22.
- 4) "Foam polystyrene packaging" means packaging made primarily from foam polystyrene that satisfies one of the following criteria:
 - a) Is designed for serving food or beverages.
 - b) Consists of loose particles intended to fill space and cushion the packaged article in a shipping container.
 - c) Consists of rigid materials shaped to hold and cushion the packaged article in a shipping container.
- 4) "Garbage" mean all solid waste, including food waste, non-recyclable materials, and other refuse generated by residential, commercial, or industrial activities, excluding hazardous waste, construction debris, large items, and e-waste.
- 5) "Glass Container" means a glass bottle, jar or other packaging container used to contain a product that is the subject of a retail sale and does not include ceramic cups, dishes, oven ware, plate glass, safety and window glass, heat-resistant glass such as pyrex, lead based glass such as crystal, or TV tubes.
- 6) "HDPE" means high density polyethylene, labeled by the resin code # 2.
- 7) "Large Items" means items such as furniture, appliances (e.g., refrigerators, washers), and similar bulky items not suitable for standard garbage containers.
- 8) "LDPE" means low density polyethylene, labeled by the resin code # 4.
- 9) "Magazines" means magazines and other materials printed on similar paper.
- 10) "Major appliance" means a residential or commercial air conditioner, clothes dryer, clothes washer, dishwasher, freezer, microwave oven, oven, refrigerator, furnace, boiler, dehumidifier, water heater or stove.
- 11) "Multiple-family dwelling" means a structure containing 5 or more residential units, including units that are occupied seasonally.
- 12) "Newspaper" means a newspaper and other materials printed on newsprint.
- 13) "Non-residential facilities and properties" means commercial, retail, industrial, institutional and government facilities and properties. Non-residential facilities and properties includes any location at which goods or services are provided or manufactured, including locations under construction, demolition, or remodeling, or used for special events such as fairs, festivals, sport venues, conferences, and exhibits. This term does not include multiple family dwellings.
- 14) "Office paper" means a variety of high-grade printing and writing papers. This term does not include industrial process waste, newspaper or packaging.
- 15) "Other resins or multiple resins" mean plastic resins labeled by the resin code # 7.
- 16) "Person" includes any individual, corporation, limited liability company, partnership, association, local government unit, as defined in s. 66.0131(1)(a), Wis. Stats., state agency or authority or federal agency.
- 17) "PETE" or "PET" means polyethylene terephthalate, labeled by the resin code # 1.
- 18) "Plastic container" means an individual, separate, rigid plastic bottle, can, jar or carton, except for a blister pack, that is originally used to contain a product that is the subject of a retail sale.

- 19) "Postconsumer waste" means solid waste other than solid waste generated in the production of goods, hazardous waste, as defined in s. 291.01(7) Wis. Stats., waste from construction and demolition of structures, scrap automobiles, or high-volume industrial waste, as defined in s. 289.01(17)., Wis. Stats.
- 20) "PP" means polypropylene, labeled by the resin code # 5.
- 21) "PS" means polystyrene, labeled by the resin code # 6.
- 22) "PVC" means polyvinyl chloride, labeled by the resin code # 3.
- 23) "Recyclable materials" includes lead acid batteries; major appliances; waste oil; yard waste; aluminum containers; corrugated paper or other container board; foam polystyrene packaging; glass containers; magazines; newspaper; office paper; rigid plastic containers, including those made of PETE, HDPE, PVC, LDPE, PP, PS and other resins or multiple resins; steel containers; waste tires; and bi-metal containers.
- 24) "Recycling Shed" The designated facility for garbage, recycling, and e-waste drop-off located at the Town of Eden Town Hall, 302 Division St, Cobb, WI.
- 25) "Resident" Any person or entity occupying a property within the Town of Eden.
- 26) "Solid waste" has the meaning specified in [s. 289.01\(33\), Wis. Stats.](#)
- 27) "Solid waste facility" has the meaning specified in [s. 289.01\(35\), Wis. Stats.](#)
- 28) "Solid waste treatment" means any method, technique or process which is designed to change the physical, chemical or biological character or composition of solid waste. "Treatment" includes incineration.
- 29) "Waste tire" means a tire that is no longer suitable for its original purpose because of wear, damage or defect.
- 30) "Yard waste" means leaves, grass clippings, yard and garden debris and brush, including clean woody vegetative material no greater than 6 inches in diameter. This term does not include stumps, roots or shrubs with intact root balls.

1.11 Separation of Recyclable Materials. Occupants of single family and 2-to-4-unit residences, multiple-family dwellings and non-residential facilities and properties shall separate the following materials from postconsumer waste:

- 1) Lead acid batteries
- 2) Major appliances
- 3) Waste oil
- 4) Yard waste
- 5) Aluminum containers
- 6) Bi-metal containers
- 7) Corrugated paper or other container board
- 8) Foam polystyrene packaging
- 9) Glass containers
- 10) Magazines
- 11) Newspaper
- 12) Office paper
- 13) Rigid plastic containers made of PETE, HDPE, PVC, LDPE, PP, PS, and other resins or multiple resins
- 14) Steel containers
- 15) Waste tires

1.12 Separation Requirements Exempted. The separation requirements of s. 1.11 do not apply to the following:

- 1) Occupants of single family and 2-to-4-unit residences, multiple-family dwellings and non-residential facilities and properties that send their postconsumer waste to a processing facility licensed by the Wisconsin Department of Natural Resources that recovers the materials specified in s. 1.11 from solid waste in as pure a form as is technically feasible.
- 2) Solid waste which is burned as a supplement fuel at a facility if less than 30 % of the heat input to the facility is derived from the solid waste burned as supplement fuel.
- 3) A recyclable material specified in s. 1.11(5) through (15) for which a variance has been granted by the Department of Natural Resources under s. 287.11(2m), Wis. Stats., or s. NR 544.14, Wis. Adm. Code.

1.13 Care of Separated Recyclable Materials. To the greatest extent practicable, the recyclable materials separated in accordance with s. 1.11 shall be clean and kept free of contaminants such as food or product residue, oil or grease, or other non-recyclable materials, including but not limited to household hazardous waste, medical waste, and agricultural chemical containers. Recyclable materials shall be stored in a manner which protects them from wind, rain, and other inclement weather conditions.

1.14 Management of Lead Acid Batteries, Major Appliances, Waste Oil and Yard Waste. Occupants of single family and 2-to-4-unit residences, multiple-family dwellings and non-residential facilities and properties shall manage lead acid batteries, major appliances, waste oil, and yard waste as follows:

- 1) Lead acid batteries shall be taken by residents or assigns to scrap metal operations or retail stores.
- 2) Major appliances shall be taken by residents or assigns to scrap metal operations.
- 3) Waste oil shall be taken by residents or assigns to retail stores or other authorized disposal site.
- 4) Yard waste shall be home composted.

1.15 Preparation and Collection of Recyclable Materials. Except as otherwise directed by the Town of Eden, Iowa County, Wisconsin, occupants of single family and 2-to-4-unit residences shall do the following for the preparation and collection of the separated materials specified in s. 1.11(5) through (15):

- 1) Aluminum containers shall be clean, free of contaminants and delivered to the Recycling shed at the Town of Eden Town Hall, 302 Division St, Cobb, WI and placed in approved containers. Alternatively, arrangements may be made with an approved alternative complying with this ordinance.
- 2) Bi-metal containers shall be clean, free of contaminants and delivered to the Recycling shed at the Town of Eden Town Hall, 302 Division St, Cobb, WI and placed in approved containers. Alternatively, arrangements may be made with an approved alternative complying with this ordinance.

- 3) Corrugated paper or other container board shall be flattened, clean, free of contaminants and delivered to the Recycling shed at the Town of Eden Town Hall, 302 Division St, Cobb, WI and placed in approved containers. Alternatively, arrangements may be made with an approved alternative complying with this ordinance.
- 4) Foam polystyrene packaging shall be clean, free of contaminants and delivered to the Recycling shed at the Town of Eden Town Hall, 302 Division St, Cobb, WI and placed in approved containers. Alternatively, arrangements may be made with an approved alternative complying with this ordinance.
- 5) Glass containers shall be clean, free of contaminants and delivered to the Recycling shed at the Town of Eden Town Hall, 302 Division St, Cobb, WI and placed in approved containers. Alternatively, arrangements may be made with an approved alternative complying with this ordinance.
- 6) Magazines shall be clean, free of contaminants and delivered to the Recycling shed at the Town of Eden Town Hall, 302 Division St, Cobb, WI and placed in approved containers. Alternatively, arrangements may be made with an approved alternative complying with this ordinance.
- 7) Newspaper shall be clean, free of contaminants and delivered to the Recycling shed at the Town of Eden Town Hall, 302 Division St, Cobb, WI and placed in approved containers. Alternatively, arrangements may be made with an approved alternative complying with this ordinance.
- 8) Office paper shall be clean, free of contaminants and delivered to the Recycling shed at the Town of Eden Town Hall, 302 Division St, Cobb, WI and placed in approved containers. Alternatively, arrangements may be made with an approved alternative complying with this ordinance.
- 9) Rigid plastic containers shall be clean, free of contaminants and delivered to the Recycling shed at the Town of Eden Town Hall, 302 Division St, Cobb, WI and placed in approved containers. Alternatively, arrangements may be made with an approved alternative complying with this ordinance.
- 10) Steel containers shall be clean, free of contaminants and delivered to the Recycling shed at the Town of Eden Town Hall, 302 Division St, Cobb, WI and placed in approved containers. Alternatively, arrangements may be made with an approved alternative complying with this ordinance.
- 11) Waste tires shall be properly disposed of through a facility that handles waste tires. The Town does not handle waste tires.

1.16 Responsibilities of Owners or Designated Agents of Multiple-Family Dwellings.

- 1) Owners or designated agents of multiple-family dwellings shall do all of the following to recycle the materials specified in s. 1.11(5) through (15):
 - a) Provide adequate, separate containers for the recycling program established in compliance with the ordinance. The number of recycling containers shall equal or be greater than the number of trash containers and at least one of the following shall be met:
 - i. The minimum total volume of recycling container space is equal to 20 gallons per week per dwelling unit.

- ii. The ratio of trash container volume to recycling container volume is at most 2:1.
 - iii. An alternative method that does not result in the overflow of a recycling container during the time period between collection of materials and delivery to a recycling facility.
 - b) Notify tenants in writing at the time of renting or leasing the dwelling and at least semi-annually thereafter about the established recycling program.
 - c) Provide for the collection of the materials separated from the solid waste by the tenants and the delivery of the materials to a recycling facility.
 - d) Notify tenants which materials are collected, how to prepare the materials in order to meet the processing requirements, collection methods or sites, and locations of drop-off collection sites to recycle materials not collected on-site.
- 2) The requirements specified in 1) do not apply to the owners or designated agents of multiple-family dwellings if the postconsumer waste generated within the dwelling is treated at a processing facility licensed by the Department of Natural Resources that recovers for recycling the materials specified in s. 1.11(5) through (15) from solid waste in as pure a form as is technically feasible.

1.17 Responsibilities of Owners or Designated Agents of Non-Residential Facilities and Properties.

- 1) Owners or designated agents of non-residential facilities and properties shall do all of the following to recycle the materials specified in s. 1.11(5) through (15):
- (a) Provide adequate, separate containers for the recycling program established under this section. The total volume of recycling containers shall be sufficient to avoid overflow during the time period between collection of materials and delivery to a recycling facility.
 - (b) Notify in writing, at least semi-annually, all users, tenants and occupants of the properties about the established recycling program.
 - (c) Provide for the collection of the materials separated from the solid waste by the users, tenants and occupants and the delivery of the materials to a recycling facility.
 - (d) Notify users, tenants and occupants which materials are collected, how to prepare materials in order to meet the processing requirements, collection methods or sites, and locations of drop-off collection sites to recycle materials not collected on-site.
- 2) The requirements specified in 1) do not apply to the owners or designated agents of non-residential facilities and properties if the postconsumer waste generated within the facility or property is treated at a processing facility licensed by the Department of Natural Resources that recovers for recycling the materials specified in s. 1.11 (5) through (15) from solid waste in as pure a form as is technically feasible.

1.18 Prohibitions on Disposal of Recyclable Materials Separated for Recycling.

No person may dispose of in a solid waste disposal facility or burn in a solid waste treatment facility any of the materials specified in s. 1.11 (5) through (15) that have been separated for recycling, except waste tires may be burned with energy recovery in a solid waste treatment facility.

1.19 Enforcement.

- 1) For the purpose of ascertaining compliance with the provisions of this ordinance, any authorized officer, employee or representative of the Town of Eden may inspect recyclable materials separated for recycling, postconsumer waste intended for disposal, recycling collection sites and facilities, collection vehicles, collection areas of multiple-family dwellings and non-residential facilities and properties, and any records relating to recycling activities, which shall be kept confidential when necessary to protect proprietary information. No person may refuse access to any authorized officer, employee or authorized representative of the Town of Eden who requests access for purposes of inspection, and who presents appropriate credentials. No person may obstruct, hamper, or interfere with such an inspection.
- 2) Any person who violates a provision of this ordinance may be issued a citation by the Town Clerk to collect forfeitures. The issuance of a citation shall not preclude proceeding under any other ordinance or law relating to the same or any other matter. Proceeding under any other ordinance or law relating to the same or any other matter shall not preclude the issuance of a citation under this paragraph.
- 3) Penalties for violating this ordinance may be assessed as follows:
 - a. Any person who violates s. 1.18 may be required to forfeit \$50 for a first violation, \$200 for a second violation, and not more than \$2000 for a third or subsequent violation.
 - b. Any person who violates a provision of this ordinance, except s. 1.18, may be required to forfeit not less than \$10 or more than \$1000 for each violation.
 - c. Appeals, residents may appeal penalties in writing to the Town Board within 30 days of receiving a violation notice.

1.20 Recycling Shed Hours and Drop-Off Procedures

- 1) Operating Hours: The Recycling Shed at the Town of Eden Town Hall, 302 Division St, Cobb, WI, shall be open for drop-off on Wednesdays from 12:00 PM to 8:00 PM and Saturdays from 7:00 AM to 12:00 PM.
- 2) Drop-Off Procedures: Residents shall place garbage, recyclable materials, and e-waste in the designated areas or containers at the Recycling Shed. Materials must be sorted and deposited according to posted signage or instructions provided by Town staff. E-waste must be placed in the designated e-waste container.
- 3) Prohibited Placement: No garbage, recyclable materials, or e-waste may be left at the Recycling Shed outside of designated operating hours or in unauthorized areas.

1.21 Prohibited Activities

- 1) Illegal Dumping: Depositing garbage, recyclables, e-waste, construction materials, or large items outside the Recycling Shed, during non-operating hours, or in

unauthorized locations, including public or private property without permission, is prohibited.

- 2) Burning: Burning of garbage, recyclable materials, or e-waste is prohibited, except as permitted under Wisconsin DNR regulations for yard waste.
- 3) Contamination: Placing non-recyclable materials in recycling containers, non-approved e-waste in e-waste containers, or hazardous waste in garbage containers is prohibited.
- 4) Scavenging: Unauthorized removal of garbage, recyclables, or e-waste from the Recycling Shed is prohibited.

1.22 Special Waste and Exclusions

- 1) Hazardous Waste: Hazardous materials, including but not limited to batteries (except as specified for e-waste), chemicals, and paints, shall not be placed in garbage, recycling, or e-waste containers. Residents must dispose of such materials at designated Iowa County or state-approved facilities.
- 2) Electronic Waste (E-Waste): E-waste must be placed in the designated e-waste container at the Recycling Shed. Approved e-waste includes:
 - a. Computers (desktops, laptops, tablets)
 - b. Monitors (CRT, LCD, LED)
 - c. Televisions
 - d. Printers, scanners, and copiers
 - e. Keyboards, mice, and other computer peripherals
 - f. Cell phones and other portable communication devices
 - g. Consumer electronics (e.g., DVD players, stereos, gaming consoles)
 - h. Rechargeable batteries (e.g., lithium-ion, nickel-cadmium) used in electronic devices
 - i. Non-approved e-waste, such as items containing hazardous materials not listed above, must be disposed of at designated Iowa County or state-approved facilities.
- 3) Construction Materials and Large Items: Construction materials (e.g., lumber, drywall, concrete) and large items (e.g., furniture, appliances such as refrigerators or washers) are not permitted at the Recycling Shed. Residents must dispose of these items at designated Iowa County or state-approved facilities.

- 4) Yard Waste: Yard waste, including grass clippings, leaves, and branches, shall be managed in accordance with Iowa County regulations and may not be placed in garbage, recycling, or e-waste containers unless specified by the Town.

1.23 Repeal of Prior Ordinance, this ordinance repeals and replaces the Recycling Ordinance dated January 1, 1995 and amends Garbage and Recycling Ordinance 20252 dated November 3, 2025.
