Regular Monthly Board Meeting Minutes

1. Meeting was called to order by Chairman Rick Zemlicka
 - Roll call was taken, other town board members present were Dennis Pierick (Supervisor), Jacob Hamilton (Supervisor), Brian Yanna (Patrolman), Cheryl Kelley (Clerk), Jennifer Thomas (Treasurer)
 - Others present: Carl Thorgsen (Scott's Construction), Kevin Wienkes, Wayne Grimm, Lisa Cvengros, Jim Smith, Kathy Ladd, Pam Redell.
 - Verification of Public Notice moved by Dennis, Jacob seconded the motion. Motion carried
2. Cheryl Kelley read the minutes of the April special meeting. Jacob moved to accept the minutes as read. Dennis seconded the motion. Motion carried.
3. Jennifer Thomas read the treasurer's report. Monthly bills were presented and discussed. Jacob moved to accept the bills as presented. Dennis seconded the motion. Motion carried.
4. Citizens and Delegations

5. Unfinished Business - None
6. New Business
 - Rick informed the board about Utility Shared Revenue – 2025 Estimate. See attached.
 - The board discussed the future road work of culverts to be replaced and sealcoat of town roads. Jacob moved to set June 2 at 7:00 pm, at the Town meeting, for accepting sealed bids. Dennis seconded the motion. Motion carried.
 - The board discussed the swap of Tucker Lane, to Town of Linden, and Sinbad Road, to the Town of Eden. Dennis moved that Rick would call to inform the Town of Linden. Jacob seconded the motion. Motion carried.
 - The board discussed the bond required for the Treasurer. Discussion tabled to the November meeting.
 - Cheryl presented a quote from Inter-Quest for maintaining a eden.wi.gov email address. Andrew informed the board that the town is not in need of a gov email address for voting purposes due working with Iowa County in the election process.
 - Brian reported the new truck equipment options and some items were ordered incorrectly. Jacob motioned to table the discuss new truck equipment options until the next months meeting. Dennis seconded the motion. Motion carried.
 - The board discussed clean and paint of the Town Hall. Storage and replacing of voting booths to removable tables. Jacob motioned that he will call school for list of students interested in community service to help with clean of Town Hall, stain the split rail fence and clean garbage/recycle shed. Dennis seconded the motion. Motion passed. Jacob motioned that Cheryl purchase cleaning supplies and 6 totes. Dennis seconded

the motion. Motion passed.

- Rick discussed the decommissioning of the first bathroom stall to convert to storage room. Jacob motioned that Rick to acquire bid to decommission (remove toilet, sink and cap plumbing) bathroom. Dennis seconded the motion. Motion carried.
 - Jacob motion to purchase two collapsable voting booths and offer the existing booth to whoever may want it or scrape. Dennis seconded the motion. Motion carried.
7. Discussion on how often the Town Board gets paid. Jacob motioned to change from yearly payroll to quarterly payroll. Dennis seconded motion. Motion carried. Jacob motioned to rescind his previous motion and change motion for Dennis to contact Wisconsin Towns Association (WTA) for guidance for quarterly payroll instead of the current yearly time period. If WTA validates change, then Town of Eden to change to quarterly payroll for board members. Dennis seconded the motion. Motion carried.
 8. Patrolman's Report- Brian brought a sample rock (quartz from Rock Springs) for the board to review. Kevin Wienkes discussed ideas to stop the gravel washing out on Tower Road. Brian reported four more bad culverts, Laufenberg, two on Plank, and Mt. Hope. Brian also requested a new electric grease gun. Jacob motioned for Brian to purchase an electric grease gun of his choosing and submit for reimbursement. Dennis seconded the motioned. Motion carried.
 9. Jacob moved to adjourn the meeting. Dennis seconded the motion. The meeting was adjourned.
